- Engineering Certificate (for those erecting temporary structures)
- List of staff that require accreditation

4. Further details including a map with your site location will be issued to you in the lead up to the Event. Please note that your final location is at the promoter's discretion and can be changed at any time up until Event day due to unforeseen circumstances.
